PROCEDURES AND PROCESSES

- A set of standardized procedures and guidelines should be adopted
- Automation and reduction of human factor by implementing new technologies and detailed regulations
- Implementation of the efficient monitoring and control system, where removal of human factor is impossible
- Integration of all processes in order for them to function as a single mechanism



SYSTEMATIZATION OF LEGISLATION

- Creation of comprehensive single set of unified legal regulations on the secondary law level (not within the Customs Code)
- Clear, accessible and transparent structure and revised (where necessary) content
- Establishing a detailed roadmap for harmonization of the Ukrainian and EU customs legislation
- Practical launch of AEO regime



CUSTOMS VALUATION

- Setting up Customs Centre for Price Information
- Building up customs capacities via applying best practices in accordance with
 Customs Valuation Compendium (EU) and Customs Valuation Encyclopedia (USA)
- New comprehensive guidelines on customs valuation shall be adopted and new permanent monitoring unit established



IT AND RISK ANALYSIS

- Comprehensive audit of all processes, equipment and software used by SFSU and customs offices
- Modernization of the system based on audit results
- Integration into international customs system (NCTS and CTS)
- Modernization of the automated risk analysis and management system



NEW EQUIPMENT AND INVENTORY

- Development and introduction of equipment and hardware standards for SFSU
- Focus is on customs capacity building, automation of the customs procedures,
 build-up of control mechanisms and prevention of corruption
- Combining available customs infrastructure into a new analytical system, which shall become source of information for risk analysis
- Efficient allocation of available resources



COORDINATION BTW AUTHORITIES

- Implementation of 'single window' principle, electronic information exchange between customs and other authorities
- Development of the risk analysis systems of the customs and other state authorities
- The road map for "Free Export" should be adopted
- Systemic coordination and communication between various state entities



INSTITUTIONAL REFORM

- Comprising all tasks and processes of customs control, customs clearance, security,
 personnel and information policy
- Introduction of the inter-agency Targeting Center
- Implementation of the concept of front and back-offices



INTERNATIONAL COOPERATION

- Implementation of best international practices in customs control and customs clearance
- Set up of full scale information exchange between customs authorities of Ukraine and those of other countries
- Integration into the global security systems
- Cooperation between border customs offices and checkpoints



HR/ANTI CORRUPTION POLICY

- Increase of the basic salary for customs officers
- Systemic enforcement of zero tolerance to all forms of corruption and illegal activities
- Establishment of new rewards and promotion systems
- The police reform in Ukraine can serve as a proper example of attracting new professional and well motivated staff



INFRUSTRUCTURE POLICY

- Implementing standards for customs infrastructure items in order for them to be compatible with the goals of customs and border protection requirements
- Following best practices in regulating and managing customs infrastructure
- Introduction of transparent rules for functioning of the privately owned types of infrastructure in order to attract investments



PUBLIC RELATIONS POLICY

- The goal of the new policy would be to create positive image of the reformed customs authority
- Promotion program needs to be developed and adopted
- Communication Center shall be set up that would monitor the pace of customs reforms, report progress to citizens and channel their feedback



CUSTOMS DATA SECURITY

- Comprehensive security audit of customs data is required
- After the audit adoption of a complex roadmap to prevent unauthorized intervention into the customs IT systems, data leaks and implement new steps for data protection
- Further development of electronic services and electronic document exchange
