#### MAJOR CHALLENGES

- Dependence on the Parliament's and Cabinet's decisions on key issues (establishment of the positions of 5 deputies in the SFS, increasing salary rates, creation of Financial Investigation Service etc.)
- Outdated technical/IT resources
- Lack of financial support/proper budgets
- Occasional misperception of the SFS image and its reforms by the general public
- Low level of trust and reluctance of the general public to engage in reforms



#### PRIORITY NEEDS FOR 2016

#### I. Customs Control and Security

- Development of the border infrastructure
- IT Support for implementation of the Authorized Economic Operators (AEO)
- Development and implementation of Advance Passenger Information System (APIS)
- Development and implementation of Cargo Targeting System (CTS)
- Review and strengthening of the customs enforcement capabilities



#### PRIORITY NEEDS FOR 2016

#### II. Taxation of Legal Entities

- Assistance in segregating different taxpayers groups within the system
- Development of the Compliance Plan
- Expert and IT support for development of electronic services and tools (automated systems for excise duty administration, e-reporting, e-audit etc.)



#### PRIORITY NEEDS FOR 2016

#### III. Large Taxpayers

- Expert assistance in execution of real-time audit by Large Taxpayers Offices (LTO)
- IT support for e-services provision in the LTOs
- Consultations on management of business processes in the Central LTO



#### PRIORITY NEEDS FOR 2016

#### IV. Tax and Customs Audit

- Studying the experience of collaboration between tax and customs officials while conducting customs audit – global expertise
- Development of Automated System of Risks Analysis and Management



#### PRIORITY NEEDS FOR 2016

#### V. Financial Investigation (1)

- Development of a "tax gap projects" to assess the scope of the 'shadow economy'
- Studying the best practices in: preventing money laundering and financing terrorism; revealing illegal practices with VAT; using indirect methods for estimation of individuals' tax liabilities
- Consultations on mechanisms of detection, prevention and elimination of tax evasion schemes, in particular salary payments by means of 'shadow funds' (salary in envelopes)



#### PRIORITY NEEDS FOR 2016

#### V. Financial Investigation (2)

- Workshops on risks selection for conducting audit on tax evasion
- Consultations on the mechanisms of processing and assessment of the information on individuals' income received by from abroad, their capital situated abroad, bank accounts in foreign banks, participation in foreign entities
- Consultations on the mechanism of declaration (legalization) of income from which taxes have not been paid



#### PRIORITY NEEDS FOR 2016

#### VI. Organizational Support

- Review and reengineering of the business processes (BPR):
- assistance on development of the proper methodology, templates of documents;
- staff training;
- advice on analysis of BPR results and improvement of business processes



#### PRIORITY NEEDS FOR 2016

#### VII. HR (1)

- Studying the best world practices of reforming HR function
- Development of the standards of professional behavior
- Program on requalification of the retired staff
- Acquisition of tests for testing the staff of the regional offices



#### PRIORITY NEEDS FOR 2016

#### VII. HR (2)

- Developing the Performance Management System
- Creating a platform for internal communications
- Diagnosis of tax and customs educational institutions of SFS, developing competitive, up-to-date educational programs; providing technical support



#### PRIORITY NEEDS FOR 2016

#### VIII. Anticorruption

- Acquisition of tests for integrity, work ethics and work stability assessments
- Trainings for staff to develop zero tolerance to corruption
- Trainings for staff of internal security division on the best practices of corruption investigation



#### PRIORITY NEEDS FOR 2016

#### IX. Appeals and Court Disputes Support

- Consultations on implementation of alternative disputes resolution
- Assistance in organizational restructuring of appeal system into a centralized one-level system
- IT support for creation of the SFS data base of legal practices and decisions
