

Logo Usage

Exclusion zone or clear space around the Chamber logo varies in direct proportion to the size of the unit. It is the minimum distance allowed between the logo and other elements such as graphics, type or the edge of the page.

Observing the exclusion zone protects the logo and prevents any other elements from obstructing it.

Regardless the size of the logo always surround it with minimum clear space equivalent to the size of the letter A.

Size of logo – to ensure integrity, legibility and clarity, logo should be reproduced in a size that is appropriate to the context in which it is used.

While there is no maximum size specified, logo should be visible but not overwhelming.



Alternative Logo

Alternative logo dedicated to the Anniversary of the Chamber activity in Ukraine (every 5 years).

Can be used only during the year of Chamber anniversary.

Ukrainian logo can be also used but English logo is prioritized.







Incorrect Usage







All kinds of distortion are prohibited as well as logo rotating.



Do not use logo on dark backgrounds without white outline around and white text





Do not use logo on cluttered or complicated backgrounds.
