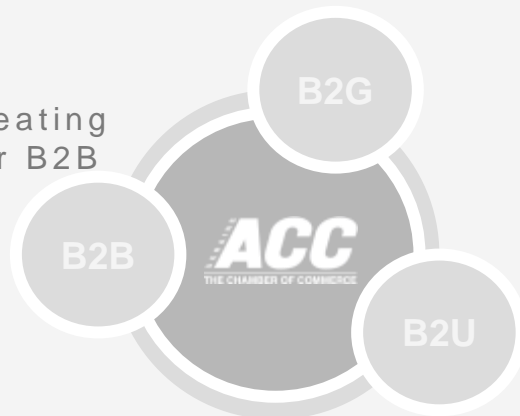

# SUCCESS STORIES: Already done in 2016



**TELECOM:** Cabinet of Ministers adopted Resolution #1160 regarding exclusion of mobile base stations from the list of activities and objects of high environmental hazard as advocated by the Chamber

**ANTIMONOPOLY:** Draft Law #2168a on Protection of Economic Competition was adopted by the Parliament with the range of Chamber proposals introduced in the final text of the document

**TAXATION:** State Fiscal Service issued the clarification #2279/7/99-99-19-02-01-17 regarding settlement of problems in the payment of CIT advanced payments of dividends which was fully advocated by the Chamber

**ENERGY:** On February 4, VRU adopted Draft Law #3074 “On Amendments to the Customs Code of Ukraine on Creation of Conditions for a New Model of the Natural Gas Market” which introduces a new definition “backhaul” with the aim of elimination of barriers for gas displacement operations

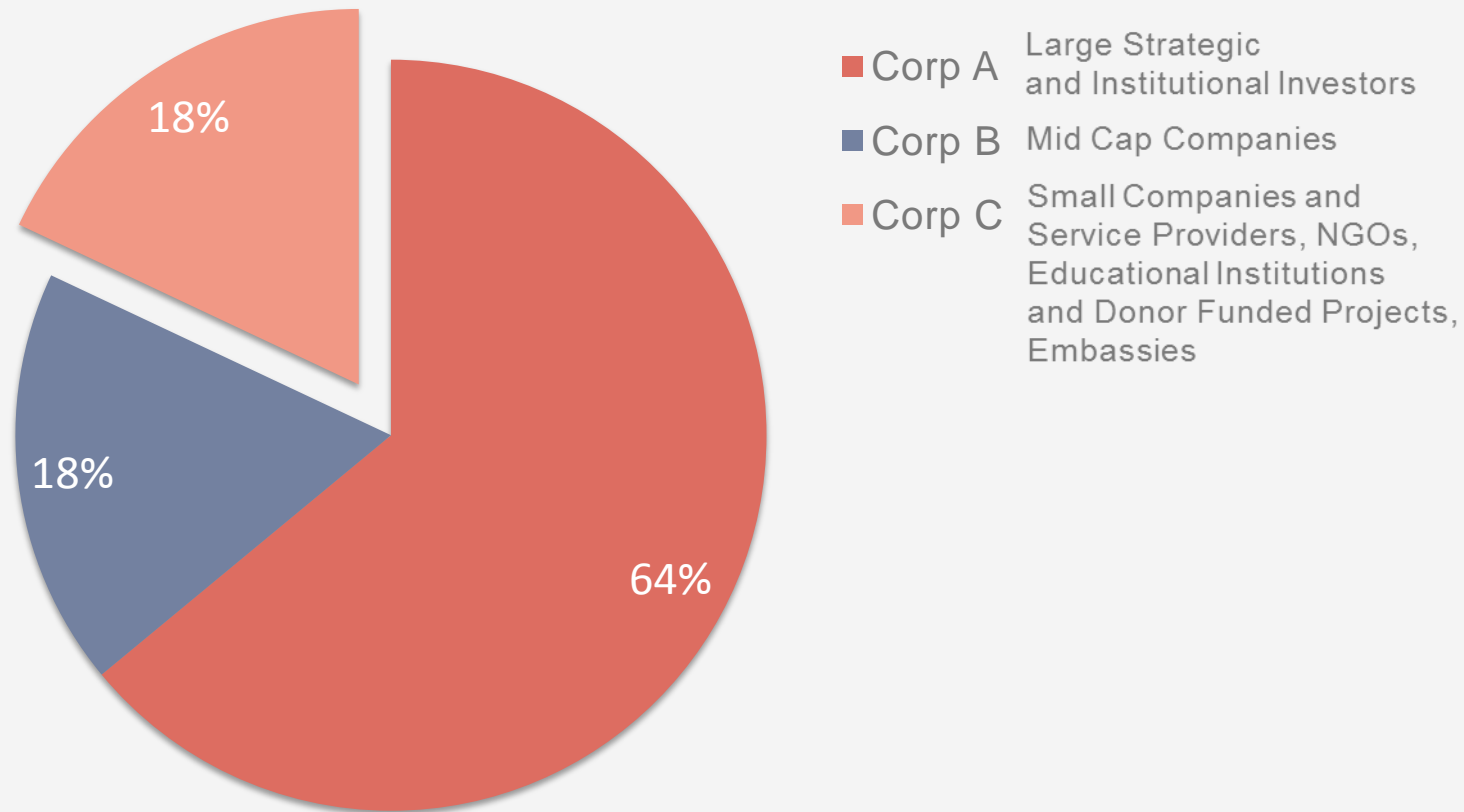

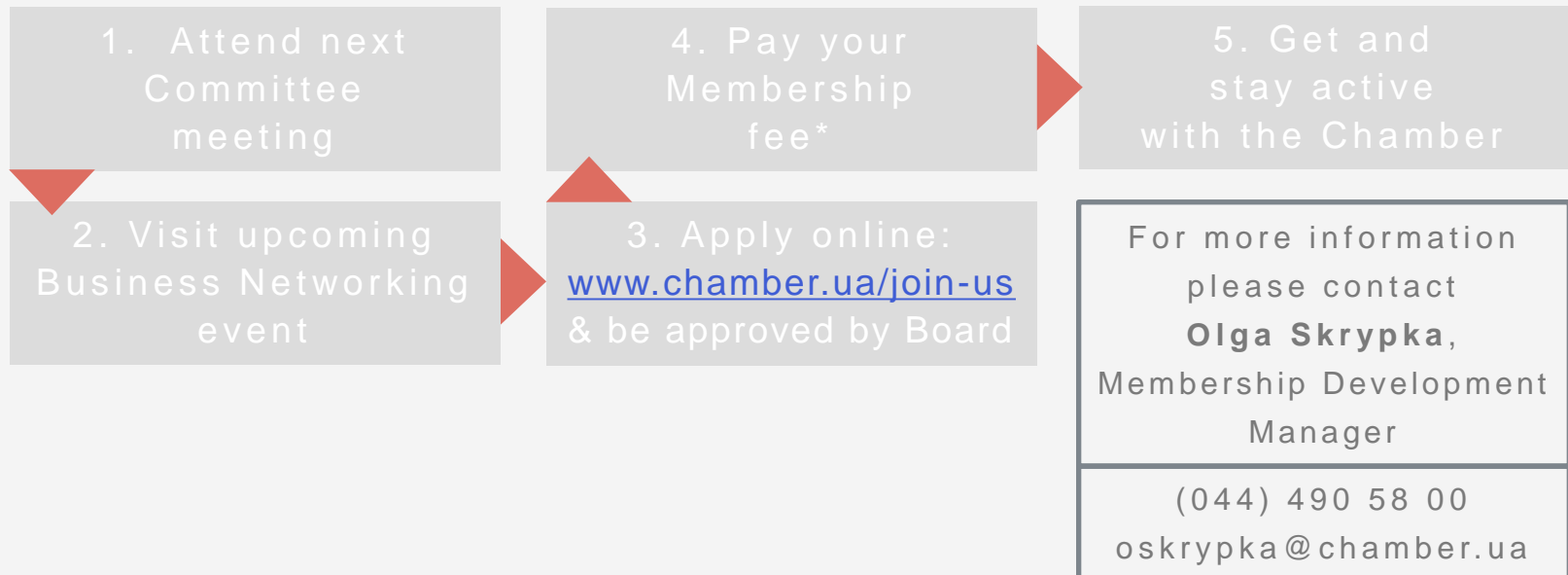
