## 3. VAT issues

In collaboration with Chamber
Tax Committee ensure
continuation of timely VAT refund
and VAT refund for previous
periods

- Verkhovna Rada of Ukraine;
- Ministry of Finance of Ukraine;
- Ministry of Agrarian Policy and Food of Ukraine;
- State Fiscal Service of Ukraine
- Ensure proper work of electronic register of VAT refund and system of blocking of tax invoices;
- Abolish provision which foresees cancellation of value added tax refund on export of soybeans, rape and sunflower;
- Develop Temporary Register on VAT refund for previous periods;
- Driving the development of criteria for blocking VAT invoices;
- Draft and promote draft law on decreasing VAT for grain and oilseeds to 10% (new draft or amending draft law 7420-2).

## 4. Reforming of Phytosanitary System of Ukraine

In particular, pass the Draft Law #6673 dated July 6, 2017 on demonopolization of phytosanitary expertise through admission of private laboratories to the market
