Oleksii Shershnov is a co-founder and shareholder of the medical company ilaya TM , a unique biotechnological and healthcare provider in the Ukrainian health and biosciences sector.





In 2003, while as a student of Odessa I.I. Mechnykov National University, Mr. Shershnov achieved a top management position at PRAVEX BANK PJSCCB in Kyiv, Ukraine, one of the largest private commercial banks in the country.

After the acquisition of Pravex by Intesa Sanpaolo, as the Deputy Director of the Kyiv Healthcare Department, Mr. Shershnov started a detailed study of the Ukrainian Healthcare system. During this time Oleksii evaluated the facilities and resources of the Kyiv healthcare system, and defined basic concepts and approaches to develop strategic direction for the municipal healthcare sector. In December 2010, together with his former colleague Mr. Oleksii Kotkovskyi, Mr. Shershnov established the medical company ilayaTM (Kyiv) that specializes in innovative medical technologies and carries out extensive research of biotechnologies.

Since June 2016, Mr. Shershnov is leading American Hospital Kyiv project which is an absolute novelty for Ukrainian healthcare reality. American Hospital-Kyiv will be positioned as the first ever JCI standard hospital in the country to introduce and implement Western standards of care in Ukraine and more specifically American standards that will advance the level of care in Ukraine and transform the healthcare sector forever.
