Professional Activity

In 1991, Oleksiy Vadaturskyy established NIBULON agricultural company (www.nibulon.com), and he is its General Director. NIBULON is a family business. Oleksiy Vadaturskyy and his son are its owners.

NIBULON has changed from a small firm to the company with a chain of branches, having invested more than USD 1.72 billion in the economy of Ukraine.

At present, NIBULON is a leading Ukrainian investor, agricultural producer, exporter, shipbuilder, one of the largest taxpayers, and an example of a socially responsible business. NIBULON revives Ukrainian cargo and passenger navigation, as well as shipbuilding. As a result of NIBULON's activities and its unique logistics infrastructure (which it created itself), Ukraine is renowned as a supplier of high-quality grain and as having a high level of logistics expertise.

ANSWER THE FOLLOWING QUESTIONS:
