Born in Kharkiv in 1973. Graduated from the Kharkiv University of Radioelectonics, and from the European University in Geneva with MBA in global banking and finance.

I have been working in Procter & Gamble for more than 20 years in a wide range of management positions in Ukraine, Russia and Switzerland. My core experience is in commercial operations, leading organizations, customers and category management at local and international (Central Europe, Middle East and Africa) level. In 2016 I took over the role of Ukraine General Manager. While we have gone through turbulent times in Ukraine, I have been and will remain enthusiastic about the unique opportunity to influence the business environment and contribute to the improvement of the lives of the Ukrainian consumers and citizens.

Procter & Gamble has been operating in Ukraine since 1993. During this time, we established deep market and consumer understanding allowing P&G products to be used in 80% of Ukrainians households. We
