<u>Fedir Serdiuk</u> was born on June 2, 1995, in Odesa. He is an entrepreneur, focused on safety issues, first aid expert and World Economic Forum Global Shaper.

In 2012, while studying at Odesa National University Fedir began his legal career. In 2014, with the beginning of the war in the East of Ukraine, he withdrew from University to receive provide first aid and tactical medical training for the Ukrainian military, Special Operation Forces and later police personnel.

To fund his volunteer activities, in 2015 Serdiuk founded FAST. FAST saves human lives by providing highquality practical first aid training, consulting and innovations in the safety area.

Today, among the clients of FAST there are more than 100 companies, including leading international and Ukrainian businesses: Metro Group, Kernel S.A., Metinvest B.V. companies, DTEK, PepsiCo, Carlsberg, Ukrnafta, UGV, etc. Each year thousands of people receive life-saving skills from FAST experts. FAST is an ACC Official Service Provider. Fedir serves as CEO of FAST currently.



In 2017 Fedir co-developed ZHGUT — the first in the World first aid chat-bot and co-founded Reskits LLC, a company to save lives by supplying its clients with modern first aid kits and defibrillators.

Serdiuk is a member of the Global Shapers Community. In 2019 he was chosen to represent the Community at the World Economic Forum Annual Meeting at Davos. In 2019 Fedir joined the Board of Vision Zero Ukraine organization, the chapter of the worldwide industrial safety initiative of International Social Security Agency.

Besides Fedir's intentions on improving the state of industrial safety in Ukraine, he is interested in several charitable and social projects. He advises business leaders and public officials on getting connected internationally.
