In addition, I will also be able to consolidate efforts of other experienced professionals of KPMG in Ukraine who are supporting the Chamber activities in a number of ways, including participation in activities of various Chamber committees.

How have you been active in the Chamber over the course of the last two years?

During my current tenure as a Board Member, I actively engaged in policy dialogue with top government officials. For example, in February of 2019, I was among the Chamber's representatives who met with Mr. Zelensky, who was presidential candidate at a time. At that meeting, I was engaged in active discussion of his economic platform and I highlighted to him some of the key priorities of the Chamber, such as implementation of real and effective judicial reform to ensure rule of law, continuation of cooperation with IMF in order to maintain macroeconomic stability and speed up Ukraine's economic growth.

Additionally, at KPMG in Ukraine, we are constantly supporting the Chamber with different activities as well as co-hosting Chamber events. As an example, in June 2018, we organized jointly with the Chamber the meeting, which was dedicated to prevention of conflicts of interest.
