His work in Bunge includes regional management of soft seeds crush value chain and acting as the country director for several countries, including Ukraine.

ANSWER THE FOLLOWING QUESTIONS:

Why do you think membership in the American Chamber of Commerce is important for businesses operating in Ukraine

The ACC in Ukraine has always been a unique platform and thinktank facilitating strong B2G dialogue. I was privileged to serve in the Board during my last assignment to Ukraine and insured Chamber's focus on creating a more level playing field in Ukraine for both international and local investors. Ukraine is facing many challenges due to the war and ACC is instrumental to keep focus of the Government over key industry and social priorities.

As a long-term CEO of the key market player and investor in agriculture and food sectors in Ukraine, I am fully committed to provide strategic guidance and leadership for the Board on the variety of agricultural and infrastructural issues. In the past I worked close with the ACC's Agriculture Committee to improve situation with the VAT reimbursement. I am convinced that my continues focus on the issue of VAT, maximizing grain exports and related infrastrucure issues and building support from the US Government, the European Commission, and the IMF was instrumental in solving the matter.



How have you been active in the Chamber over the course of the last two years?

Bunge has always been active in the Agricultural, Infrastructural and Tax Committees of the ACC also co-chairing some of these Committees. The martial state prompted us to switch more to the online communication but once the situation improves, I hope we can get back to in-person communication as well. As a Board member I have been an active participant of the Board meetings and keep high priority to the ag issues and also talking to varouis think tanks, agencies and donors working on providing aid to Ukraine.

As the CEO with a solid background in agriculture, I would like to be responsible for this industry and the Agricultural and Infrastructure Committees of the Chamber.
