Andrey Stavnitser is a Ukrainian entrepreneur and philanthropist, having a track record in both business and humanitarian endeavors.

As the co-owner and CEO of TIS, a largest port business in Ukraine, he steered the company to a marketleading position among private and state-owned ports. He's been instrumental in several pivotal Ukrainian infrastructure investments, including the partnership with Cargill to establish the Neptune grain terminal, also co-founded by EBRD and IFC.

In response to the 2022 Russian invasion, Stavnitser established the "Help Ukraine Center." This initiative efficiently collects and transports humanitarian aid from around the world to Ukraine, valued at approximately \$120-130 million. It includes essential supplies like food, medicine, and hygiene products.

After 3 months, Andrey initiated the <u>www.superhumans.com</u> in Lviv - a high-quality medical clinic specializing in prosthetics, rehabilitation, reconstructive surgery and PTSD. The center operates with the support of Howard Buffet and Richard Branson, and organizations as Mastercard, LVMH, Payoneer, Cargill, CMS, PrivatBank, SoftServe, SOCAR and many others. The First Lady of Ukraine and the Minister of Healthcare are serving as Board members for Superhumans.

Andrey is currently serving as a Board Member for the Aspen Institute Kyiv and the National Jewish Congress. He also is the Honorary Consul of Austria in the Odessa Region. His educational background includes Harrow House UK, Instiitute Montana Switzerland and a degree at Stanford University GSB.

Andrey Stavnitser is married with four children. Andrey's wife, Diana Stavnitser, is a fashion-designer, founder of a Ukrainian fashion brand "DiStavnitser"

#### ANSWER THE FOLLOWING QUESTIONS:

Why do you think membership in the American Chamber of Commerce is important for businesses operating in Ukraine?

Having created multiple joint ventures with multinational corporations, I strongly believe that attracting international business to Ukraine and supporting their establishment in the country improves local business standards, strengthens anti-corruption practices, and generally elevates Ukraine's position on the 'doing business' scale. Ukraine is a country of talented, hardworking, and dedicated people who need some assistance in overcoming the post-Soviet remnants, and this is precisely what prominent international organizations, such as the Chamber, are doing.

I have great respect for the work AmCham is doing and am truly grateful for how the Association has stood by Ukraine during the war. Participating in significant professional discussions and seizing opportunities to contribute is of great importance to me.

I believe I have extensive knowledge of what large international businesses need in order to invest in Ukraine. My deep expertise in logistics and infrastructure allows me to believe that I can make a significant contribution when addressing issues that are crucial for both businesses and the state. Having been deeply involved in Superhumans for over a year, I also have knowledge of how businesses should integrate veterans into their operations and how the medical system functions.

How have you been active in the Chamber over the course of the last two years?

TIS has been a long-standing member of the Chamber, and our representatives are active participants in the Infrastructure Committee. We have taken part in various activities and processes initiated by the Chamber, supported the Chamber's public statements, and maintained an ongoing dialogue with the management and the members throughout these years.
